Halifax Board of Health Meeting Minutes Wednesday, March 05, 2014

On Wednesday, a meeting of the Halifax Board of Health was held in the Board of Health office at 7:00 p.m.

 - 7:15pm Monponsett Street 200' Grid by-law for multi unit housing Charlie Woodward
 - 1. Charlie Woodward was in attendance. He updated the Board on where the development and septic systems will go and explained the preliminary of the development. He avowed he is seeking guidance that he is moving in the right direction in accordance with the 200' grid by-law (Zoning by-law). Mr. Woodward described to the Board his concept of evaluation of the 200' grid by-law and stated he tried to be consistent and fair and stay within accordance of the by-law which is ambiguous. Mr. Woodward stated the health agent was there during the soil evaluations and the health agent stated she is comfortable the soil evaluations done. The Board is in agreement Mr. Woodward did everything to abide to the by-law and approved his concept of his evaluation of the 200' grid.
 - ii. 7:30pm -12 Water Street Paul Jenner Title V Inspection Report Water Street.
 - 1. Mr. Paul Jenner, Title V Inspector was requested to appear but was not in attendance. Ms. Betty Heal, owner of 12 Water Street was in attendance.
 - **a.** The health agent updated the Board concerning the Title V inspection done at 12 Water Street and provided them with a copy of the inspection report. The Board was also given a copy of the emails the agent had with Mr. Jenner. The Board then turned the meeting over to Ms. Betty Heal, owner, to listen to her account on the report.

Ms. Heal stated to the Board that she moved in December of 2013 and after a week had to have the tank pumped because sewerage was backing-up into the house. The Board asked Ms. Heal if she was aware that the system at her property was a tight tank and she stated that she was. However, she also stated that to her knowledge, the tight tank was pumped as part of the Title V inspection done on June 05, 2013. She was also told by others that the house was winterized in October 2013 and that nobody lived in the house after that date until she moved in December, 2013. She stated she didn't understand why the tank would need to be pumped after

only one week if the water was shut off and she is the only one residing in the home, using limited water.

The Board explained to Ms. Heal that depending on other possible circumstances and/or water usage within the home prior to her moving in and during her current week residing in the house, it is feasible that it may have filled and needed to be pumped.

Ms. Heal asked the Board what process she would take to make this a formal complaint. The Board informed Ms. Heal that by coming before the Board tonight, she has taken the first step and made a formal complaint.

The Board requested the health agent document the complaint in letter format, contact the water department for water records from June 2013 through December 2013 and inquire with Southeast Septic regarding the pumping records. The Board requested the health agent submit the formal written complaint at their Wednesday, March 19, 2014 meeting. The Board advised the administrative assistant, should the Tile V inspector submit an application for renewal of permit, he will need to first come before the Board before a current permit will be issued.
