# Halifax Board of Health <br> Meeting Minutes Wednesday, June 18, 2014 

On Wednesday, a meeting of the Halifax Board of Health was held in the Board of Health office at 7:00 p.m.

The Board opened the discussion thanking the Pham family for attending tonight's meeting to discuss the lead paint, failed septic system and inspection of apartments at the property.

The Board informed the Pham's that the lead paint must be properly removed per DEP requirements and the septic system must be repaired immediately and it was asked if the Pham's would be in favor of the health agent inspecting the apartments on the property.

After a discussion between the Pham's, Hiep Pham asked for guidance from the Board of Health as to what they need to do to begin the process and if the health agent would be the one inspecting the apartments. The agent stated she would be the one to come and inspect the apartments and the Pham's were in agreement with that.

The Board and health agent discussed with the Pham's that they would need to hire a licensed professional to remove the lead paint according to DPH requirements and an order from the Lead Poisoning Prevention Program needs to be recorded at the registry of deeds.

The health agent informed the Phams, the Board of Health does not have a list of licensed de-leaders and they would have to go to the yellow pages or get a recommendation from someone they know. The Pham's were also told a licensed engineer would
need to be hired to design the septic system to begin the process and then a licensed installer would need to be hired to install the new system.

The administrative assistant gave the Phams a list of currentlypermitted soil evaluators and septic installers Halifax.

The Board emphasized that these actions need to begin immediately and it was agreed the Pham's would contact the office with the information as to how they have begun the process and will return to the July 02,2014 meeting with an update.

A Motion was made that there needs to be a deadline on these repair issues, the Phams will communicate by phone or in writing with the Board of Health office who was contacted or hired and what, if anything was done and the Board of Health will confirm that information. The Phams will return to the July 02, 2014 meeting to discuss their progress with this matter.

They discussed that if you take into consideration the restaurant's water flow, number of seats, number of meals, etc... using EPA's method for calculations, it demonstrates that septic systems and grease traps function best if bigger than what MDEP requires.

The Board suggested Mr. Dias and Mr. Latini use the EPA formula as guidance and a reference point as to how EPA considers the importance of sufficient storage for grease. Mr. Dias and Mr. Latini will bring the plan before the Board for approval at another time.
