# Halifax Board of Health Meeting Minutes Wednesday, September 17, 2014

On Wednesday, a meeting of the Halifax Board of Health was held in the Board of Health office at 7:00 p.m.

The Board of Health meeting opened at 7:00 p.m

### a. Recommended for Approval

- i. <u>265 Monponsett Street</u> (Halifax Trails) Greg Driscoll, JDE Engineering
  - 1. Mr. Greg Driscoll was in attendance. Mr. Driscoll presented the plan for Halifax Trails and stated at this time the plans indicate each unit sits on one (1) acre with two (2) or three (3) bedrooms per unit.

Mr. Driscoll, the Health Agent and the Board discussed the matter of the monolithic pump chamber and how the size needed for Halifax Trails is not available in monolithic and the need to know the tank was not leaking. They discussed a 48 hour water test to ensure the tank is sealed tight, and rubber (Cast) boots for the tank to create a watertight seal around the pipes entering and exiting the tank.

A Motion was made to approve as recommended with the variance of more than 36" cover over the pump chamber. The approval is also subject to the changes requested by the Health Agent. A48 hour water test of the tank, the first 24 of observation to ensure water does not leach into the tank and the second 24 hours of the tank being filled and adding rubber (Cast) boots to the tank.
