On Wednesday, a meeting of the Halifax Board of Health was held in the Board of Health office at 7:00 p.m.

The Board of Health meeting opened at 7:00p.m

 - 1. Joe Webby presented the I/A system design to the Board. Mr. the Board, Health Agent and Mr. Webby discussed with Mr. McAndrew's the issues and concerns he expressed about water pooling in one area of the property and some problems Mr. McAndrew's stated he is having with the catch basin there.
 - a. The Board and Mr. Webby agreed the swale was workable and that it would be a good idea to put one in to possibly help eliminate the water and keep it from pooling. The Board informed Mr. McAndrew's that they cannot speak or act for the Highway Department and suggested he contact them regarding the problems he states he is having with the catch basin. The Board commented to Mr. Webby, that they had no issues with waivers requested and the revisions can be made and resubmitted for approval.
 - 2. Mr. McAndrew's mentioned to the Board that his sump pump was piped into his septic tank. The Board told Mr. McAndrew's that was not allowed per Title V and they strongly recommended re-piping it to the outside.
