#### 1. Items/Appointments:

- a. 7:30pm: Eric Mueller, Jack Doucette, All Seasons 327 Plymouth Street
  - i. Discuss septic plan
    - 1. Mr. Eric Mueller updated the Board regarding the concern of back wash in the septic systems pump chamber and wants to send a camera through the weep hole/inspection port to determine if there is a problem and go forward from there.

Ms. Scherer informed the Board that she and her neighbors had a case in land court regarding the two (2) properties.

If the well is determined to be on Ms. Scherer's property, there is the option of drilling a well on their property at 15 Spring Street or the possibility of the Board of Health beginning the process to condemn the house.
