Halifax Board of Health Meeting Minutes Wednesday, September 16, 2015

On Wednesday, a meeting of the Halifax Board of Health was held at the Halifax Town hall.

Present at the meeting were:

John Weber – Co-Chairman Alan J. Dias - Clerk Cathleen Drinan – Health Agent Peggy Selter, Administrative Assistant

The Board of Health meeting opened at 7:00p.m

1. Disposal Works Permits:

- a. Ratify Agents Approval:
 - i. 374 Plymouth Street

A Motion was made to ratify health Agents approval.

b. Requiring **Local Upgrades**: (but otherwise recommended for approval):

- i. 395 Plymouth Street
 - 1. Board requested the following:
 - **a.** Include the note regarding location of streams
 - **b.** Include, on the plan, the results of the sieve analysis, including the "triangle" so that it is clear as to the soil class.
 - **c.** They noted that while the concrete poured into the bottom of the pump chamber might achieve the desired weight, it is not practical to achieve or for the Health Agent to inspect. (It was also noted that one spot says 10" and another 12".)
 - **d.** An anti-flotation "collar" at the bottom can be added as a formed ballast or a heavy cover can be added. Then, redo the buoyancy calculations for your chosen method of adding weight.
 - **e.** The aluminum hatch to grade needs to be sized and include a detailed drawing.
 - **f.** The junction box for the pump chamber is supposed to be outside of the riser/chamber.

- **g.** "Aluminum hatch to grade" what size? Also, provide a detailed drawing on the plan.
- **h.** Wiring for the alarm panel and the pump needs to be separate from the tenants' wiring. A separate "owners" panel/line will need to be established.
- i. The board wondered where the alarm panel will be located. Outside will be necessary. The installer needs that guidance.
- **j.** In the pump chamber, in addition to a stainless steel chain, rails are needed to guide the pump both out and back into the chamber for repairs, due to the depth.
- **k.** "Cover at grade". The type needs to be specified, as installers quite often will choose the least expensive and the least expensive is not secure. It needs to be secure by either being very heavy (not just bolted) or lightweight at grade, with the original concrete left in place (if that is practical/not too deep) or the cover can be under 6 to 9 inches of soil so that children are not attracted to it. Bolted and gasketed cast iron is good for at grade.

The owner(s) were instructed to do some repair/replacements to comply with the requirements per Mr. Dias's instructions and to contact the Board of Health when completed for a re-inspection.

The homeowner(s) have not contacted the Board of Health office for a re-inspection as requested.

The Board has requested the Health Agent send a letter to the homeowner(s) informing them they have failed to comply with the Board of Health requirements and send a copy of the letter to the Selectmen's office with the knowledge that the Board of Health is not

in favor of the homeowner(s) request for an extension of the trailer/camper permit.
