Halifax Board of Health Meeting Minutes Wednesday, December 16, 2015

On Wednesday, a meeting of the Halifax Board of Health was held at the Halifax Town hall.

Present at the meeting were:

John DeLano – Chairman Alan J. Dias - Clerk Cathleen Drinan – Health Agent Peggy Selter, Administrative Assistant

The Board of Health meeting opened at 6:30p.m

1. <u>Disposal Works Permits</u>: Donald Brown, owner & Steve Wry, Land Planning in attendance.

The Old Franklin & Hayward Street (Map 113, Lot 2) hearing opened at 6:30pm

- a. Hearing Continued 6:30 pm Old Franklin & Hayward Street (Map 113, Lot 2) Requesting Variances from "Soils of Special Concern"
 - i. At the 11/16/15 the Board suggested Percs be done to show that soils are not usable in other locations other than where the septic system is being presented on the plan.
 - ii. Requested Variances: Old Franklin & Hayward Street (Map 113, Lot 2) Steve Wry updated the Board on the revised plan, additional perc tests and reduced variances.
 - **1.** 1.06(10)(c) setback requirements
 - **a.** Property line setback to SAS 50': {29' provided} [Title V requirement 10']
 - **b.** Other open, surface of subsurface drains setback to SAS 50': {35' provided} [Title V requirement 10']
 - **2.** 1.06 (10) (d) setbacks on mounded septic system will be measured from the toe of the slope: {impervious barrier used to inhibit horizontal movement of effluent} [Title V setback requirements measured from limit of SAS]
 - **3.** 1.06 (10) (e) A 50 foot buffer strip of naturally occurring vegetation between edge of system and property line: {no existing vegetation on site except for brush line at Old Franklin Street that will remain undisturbed}
 - **a.** Land Planning and the Health Agent informed the Board that all additional perc tests done failed and the additional soils were unusable, preventing moving the septic system to another location on the property.

The Board approved the revision made extending the 40sf to 80sf lot size per the "Soils of Special Concern" regulation.

b. The Board suggested a deed restriction be recorded at the Plymouth Country registry of deeds stating "No more than one (1) family dwelling will be erected" and "The property will not be further sub-divided."

A Motion was made to continue the hearing on Old Franklin & Hayward Street (Map 113, Lot 2) which will be held at next Board of Health regular scheduled meeting on January 06, 2016 at 6:30pm.

- **b.** <u>7:00pm</u> Tobacco Regulations Continued Discussion/Vote: Mr. Gerald Co-Wallis, Jr. in Attendance.
 - i. Letters of Support Board reviewed letters of support
 - 1. American Heart Association & American Stroke Association.
 - 2. Tobacco Free Mass.
 - **3.** Letter from Mr. Gerald Co-Wallis, Jr opposing the regulations.
 - **a.** The Board asked Mr. Co-Wallis if he would like to comment.
 - i. Mr. Co-Wallis stated he sent a letter opposing the regulations and that he was here tonight to voice his opposition to the tobacco regulations.
 - **b.** The Board explained to Mr. Co-Wallis that nicotine products are a health issue and by the Board of Health passing stricter regulations it would take the incentive away from children before they even begin using the product.
 - i. Mr. Co-Wallis again stated he was against the Board of Health regulating nicotine products and would take legal action in the future should the Board of Health move forward with the passing of any tobacco regulations.
 - **c.** The Board again explained to Mr. Co-Wallis what the Board of Health was doing, why they were doing it, and that they would, in all probability, be making a decision on the regulations at tonight's meeting.
 - **d.** The Board was unanimously ready to entertain a motion to vote on the tobacco regulations.
 - **i.** The Board reviewed the items from the Board of Health December 02, 2016 meeting.
