- 2. This local upgrade approval requires the institution of a deed restriction at the subject site, disallowing any future increase in the Title V flow.
- **3.** An additional deep observation hole will be conducted at the time of system construction and if soil mottling is found, or if a new frimpter adjustment demonstrates that the required 4' SAS to groundwater vertical separation has been met with the SAS elevations specified on the plan, the deed restriction requirement will be eliminated.
