Gordon read a memo dated June 14, 2010 from the Zoning Board of Appeals regarding a "Letter of Mutual Agreement for Withdrawal" from the applicant R. Richard Lincoln Jr. of Beard-Lincoln, LLC on petition #719, the Comprehensive Permit of a project to be named Blackledge Farm on land located off Franklin Street stating that "as the mutual request and agreement of the application, the petition is hereby withdrawn without prejudice".

This project has been withdrawn and is no longer a 40B; it will be 40-50 multi-family units.

#### **Discussion:**

#### **Highland Woods**

A phone call was received by the Planning Board secretary from Bob Badore of the Highway Department regarding a catch basin that is collapsing near 6 Arrowhead Road in Highland Estates. The road construction has not been completed by the builder and this development has not been accepted by the Town. The owner of the sub-division, Larry Salters, has since passed away and we need to find out who is handling the construction. The developers are not taxed on the roads until the road has been accepted by the Town. Members Dean Jafferian and Rick Greeley asked who is responsible for making the roads taxable and if this policy could be changed. Rick Greeley suggested that the Planning Board should set up a meeting with the Assessor's to consider changing this policy.

The Board decided that we will have to "wait and see" what happens with the drainage during the next big rainfall. The secretary will contact Mr. Palmieri to let him know that at this time, he does not need to meet with the Planning Board.
