Ms. Reardon also inquired about the placement of a permanent sign as her business is not visible from the road. The Planning Board reviewed the site plans and photos for the Cumberland Farms Plaza. Ms. Reardon will have to get permission for a free-standing sign from the property owners, Cumberland Farms. The Planning Board asked Ms. Reardon to bring plans and measurements for her signs to the next Planning Board meeting on September 16, 2010.

Highland Woods

Town Administrator Charlie Seelig received a letter from Ed Gavin regarding the status of Arrowhead Path. Arrowhead Path, along with all of the other roads in the subdivision, has not been accepted by the Town. Charlie is inquiring on behalf of Mr. Gavin, about the status of a bond, usually required from the builder as a "promise" to maintain the subdivision. At the time, developer Larry Salters of Ocean Hill Inc., had lots held instead of a money bond for assurance. Member Rob Piccirilli asked if the Board should take bonds for future developments. Gordon Andrews explained that if a developer puts up the subdivision as surety, by law, the Board must accept it. Town Administrator Charlie Seelig sent a letter to Ocean Hill Inc. on September 1, 2010 with hopes of resolving some of the homeowner's complaints. The complaints include:

- 1. Lack of maintenance of the cul-de-sacs (mowing, etc.)
- 2. Lack of plowing/shoveling of snow on the sidewalks
- 3. Deterioration of the drainage systems (catch basins, etc.)

The Planning Board will keep updated.
