Meeting came to order at 6:00 p.m. with Selectmen Troy E. Garron, Kim R. Roy and Michael J. Schleiff present.

The following business was discussed:

SCHEDULED APPOINTMENT

Bella's Pizzeria II, LLC d/b/a Bella's Pizzeria II Seafood & Grille

This appointment is the continuation of the hearing that was schedule on January 11, 2011 on the application for an Alcoholic Beverage License to serve wine and malt from Anthony Muscolino of Bella's Pizzeria II, LLC d/b/a Bella's Pizzeria II Seafood & Grille located at 319 Plymouth Street.

The hearing needed to be continued because a new corporate vote needed to be taken appointing Anthony Muscolino as the Manager of the establishment. Mr. Muscolino presented the Board with the necessary vote required to continue the approval of the application.

Garron asked if he is just looking to serve beer and wine and he said yes. Muscolino was asked where would he be serving the alcohol and he said it will be served in the sit down area. Garron also asked him if he completed tips training and that also has been done and he has submitted a copy of the certificate to the Selectmen's office.

Moved by Roy and seconded by Schleiff, Board unanimously approved the Alcoholic Beverage License for Bella's Pizzeria II, LLC d/b/a Bella's Pizzeria II Seafood & Grille.

GENERAL BUSINESS

A. <u>Emergency Declaration</u>

A state of emergency was declared on January 12, 2011. The Chair, Troy Garron, was asked by Chief Carrico if he could sign an emergency declaration.

Moved by Roy and seconded by Schleiff, Board unanimously approved to have Garron sign the emergency declaration.

B. <u>Private Party at This & That Gifts</u>

Jacquelyn Rose wanted to know what she needed to do if she wanted to serve beer and wine at a private 50^{th} birthday party (fifty guests) she would like to have at the business of This & That Gifts located at 300

Plymouth Street on January 30^{th} . Ms. Rose is not the proprietor of the business but has permission from the owner to have this event at this location.

Garron did not have a problem with this but wanted to make it clear that the doors remained locked.

Moved by Schleiff and seconded by Roy, Board voted that a one day liquor license did not need to be issued for the event listed above but the following stipulations must be met:

- (a) There is no charge directly or indirectly by the proprietor of the establishment for the serving or consuming of alcohol.
- (b) The doors are to remain locked to the public.
- (c) Designate an adult to remain sober and in charge at all times.
- (d) Please inform your guests to park at the far end of the parking lot to provide parking for commercial establishments at this address.

There being no further business, moved by Schleiff and seconded by Roy, Board unanimously voted to adjourn the meeting at 6:10 p.m.
