L. A. Ruest stated that the Board has the authority to act on the request. The deed stated that the property must be used for conservation or recreational purposes. The property is located at Map 6, Lot 33-4-13, 6 acres. L. M. Smith is concerned about putting a house on a land-locked lot and coordinating with school buses, but supports use of the land for recreational purposes. E. B. Beattie would like further review. The Board directed L. A. Ruest to contact Town Attorney Bart Mayer.

J. E. Ziolkowski reported that the Selectmen reviewed the unresolved winter road maintenance repairs for posting, Town Safety Complex, 7 culverts. The wall behind the police department was reviewed and a railing is recommended.

A crater in the pavement behind the police department needs to be filled. Repair of the concrete aprons needs to be planned for the next budget cycle. Granite curbing in the front of the Public Safety Building needs repair.

L. M. Smith confirmed that all outstanding issues with winter road maintenance services have been resolved.
