C. PUBLIC HEARING

Case #12-04-01: Application from Unitil Forestry Department for Final Public Hearing for Scenic Road Alteration Permit for tree pruning on all or portions of eight (8) scenic roads in Hampton Falls.

Mr. Chris Moultroup, Forestry Supervisor of Unitil's Forestry Department reported that Unitil plans to conduct additional line-clearance pruning work along roads in Hampton Falls. He noted that an application was approved by the Board in September 2011 for a number of scenic roads and that this application is for additional scenic roads. He referred the Board to a memo submitted with the application listing the additional roads.

C. Moultroup displayed a plan and showed Board members the two circuits being maintained that are affected by the Scenic Road Alteration Permit ordinance. In response to B. Mutrie, C. Moultroup reported there are five or six circuits in Hampton Falls of which some are shared with abutting towns. A. Tonry asked if this request finishes the work to be done in Hampton Falls or whether another application is forthcoming. C. Moultroup stated he does not know at this time and that review will take place in the fall to determine if more work is to be done.

In response to A. Franciosa, C. Moultroup confirmed that he understood the six foot trimming requirement allowed by the ordinance rather than the standard of 10 feet used by Unitil and indicated the plan is to comply with the town ordinance.

Hearing no further questions of the Board, A. Franciosa opened discussion to members of the public. No members of the public were present. A. Franciosa closed the public hearing.
