- HYA: Glen Palm and Mike Fowler presented on behalf of HYA
  - Glen Palm brought up concerns about the management of the baseball diamond. Stated that throughout the summer HYA brought in their own equipment to manage the cutting of the infield. Raised concerns on the deterioration of the pitchers mound, lips in the infield, home plate is a danger issue as well as water issues with First and Second plates. Don and Larry stated awareness of drainage issue and what methods have been used previously to fix/manage situation. Glen stated HYA would be interested in taking over management of the field in exchange for not paying park fees. It was asked that HYA gather list of materials needed and areas needing maintenance. Commission will take proposal into further consideration.
