2. Town Meeting on May 10, 2011 and Budget for HBPC's work:

We need to find out about the budget for HBPC. Select Board will be reviewing now.

- Grant proposal funding is available for Carolyn Radisch's continued work.
- We should put in our request for use of the \$5.00 fees collected with yearly car registrations.

- Tim asked if bikes "trip" Park/Lyme Rd. light?
- The 2 bike boxes are on hold, but we do want one on the uphill side and later, on the downhill side.
