Z2014-22: Shumway, <u>REQUEST FOR REHEARING</u> of Z2013-38, a Variance to construct a communication/telecommunication facility greater than 30' in height at 67 Three Mile Rd.

It was moved and seconded to **GRANT** the requests for rehearing. THE BOARD VOTED THREE IN FAVOR, ONE OPPOSED (WAUGH). THE MOTION CARRIED.
