Z2015-21: WILLIAM WARE & LESLEY JARVIS, SPECIAL EXCEPTION UNDER ARTICLE II, SECTION 210.1K, "FENCES", PURSUANT TO SECTION 206, "SPECIAL EXCEPTIONS", TO CONSTRUCT A FENCE GREATER THAN 4' TALL WITHIN THE REQUIRED SIDE SETBACK AT 7 HEMLOCK ROAD, TAX MAP 47, LOT 69, IN THE "SR-1" ZONING DISTRICT.

SLOANE MAYOR FOR JONATHAN ROBERTS & JENNIFER RICKARDS, SPECIAL EXCEPTION UNDER ARTICLE VIII, SECTION 803, "CHANGE OF NON-CONFORMING STRUCTURES," PURSUANT TO SECTION 206, "SPECIAL EXCEPTIONS," TO REPLACE AN EXISTING NON-CONFORMING GARAGE WITH A GARAGE THAT IS ON THE SAME FOOTPRINT BUT IS HIGHER THAN THE EXISTING GARAGE. THE PROPERTY IS LOCATED AT 6 ETNA HIGHLANDS ROAD, TAX MAP 2, LOT 36, IN THE "RR" ZONING DISTRICT.
