#### **New Business:**

1. Minutes: The minutes from August 16, 2012 were approved.

2. Reports: Board members signed the following reports and forms:

- Motor Vehicle Abatement Report
- Warrant & Commitment for Motor Vehicle Excise Tax
- Warrant & Commitment for FY2012 Supplemental Tax Bill
- Warrant & Commitment for Sewer Betterments
- Chapter Land Tax Liens & Releases for 64 Westcott Road & 42 Old Mill Road

3. <u>Verizon ATB Case</u>: On September 7<sup>th</sup> the town received notification from Chu, Ring & Hazel LLP (the firm representing Verizon New England Inc.) concerning the tax abatement and refund due from the Town of Harvard for personal property bills from FY 2009. Since many towns in Massachusetts received similar notices, the Department of Revenue has scheduled a hearing for October 9<sup>th</sup> to discuss the abatements.

#### **Ongoing Business:**

<u>Update on Geographic Information Systems (GIS)</u>: Cartographics is actively converting all the tax map text and expects to complete that step within the next two weeks. Once complete, they will begin to build the GIS website and plan to have it ready for password review by the end of October or early November. RRG will schedule a presentation about their GIS services to the Board of Assessors and other town departments during November or December.

### Review RRG Calendar:

a. FY 2013 Statutory Exemptions: The board reviewed the statutory exemption applications for Seniors, Veterans, Blind and Surviving Spouses. The board voted 2-0 to deny one application under Clause 22D for D. Winters, and voted 2-0 to approve the remaining 21 applications.

b. FY 2014 Chapter Land applications: The board voted 2-0 to approve Chapter 61 Forestry applications for:
