New Business:

1. Minutes: The minutes from November 8, 2012 were approved.

<u>2. Reports</u>: Board members signed reports for motor vehicle abatements, motor vehicle warrants and commitments, and one Chapter Land tax lien.

3. FY2014 Chapter Land Applications: The Board reviewed the following applications:

- Massachusetts Avenue, Parcel ID 23/35, RB Realty Trust: The board voted 3-0 on a Maiore/George motion to approve the application for Chapter 61 Forestry.
- Still River Road, Parcel ID 25/32, Two Eighty Five Still River Trust (Capobianco): The board voted 2-0 on a Maiore/George motion to approve the application for Chapter 61A Agricultural/ Horticultural. Joe Theriault abstained from voting.
- 168 Bolton Road, Parcel ID 31/13, Callahan Realty Trust: The board voted 3-0 on a George/Maiore motion to approve the application for Chapter 61A Agricultural/ Horticultural.
- The board also reviewed a letter from Cynthia LaBruzzo regarding the denial of her Chapter 61A application for 146 East Bare Hill Road (Parcel ID 31/32). On a George/Theriault motion, the board voted 3-0 to stand by their original decision to deny the application. A follow-up letter will be mailed to Ms. LaBruzzo.

4. Schedule F for Chapter 61A Applications: The board agreed that Chapter 61A property owners who lease their land for no charge can submit a copy of the leasee's Schedule F as proof of income, or other documentation such as letters and receipts.

5. Abatement Procedures: The board reviewed a draft letter to residents explaining the abatement procedure for real estate and personal property taxes, and agreed not to take any action on the letter at this time.

## **Ongoing Business:**

<u>1. Update on Geographic Information System (GIS)</u>: Steve Morse from RRG is working with Sue and Linda to review the draft version of the GIS Online Query Manager developed by Cartographics.

<u>2. Review RRG Calendar</u>: Harald stated that the FY2013 tax rate recap package was submitted to the Department of Revenue in November, and the 2013 tax rate of \$16.68 was approved in early December. Real estate and personal property tax bills for FY2013 Quarter 3 and Quarter 4 will be mailed on December 31<sup>st</sup>. January mailings include statutory exemption notices, Forms of List for personal property and second homes, and 3ABC forms.
