

**BOARD OF HEALTH**  
**MINUTES OF MEETING**  
**April 8, 2008**

The Board of Health held a meeting on Tuesday, April 8, 2008 at 6:00 p.m. at the Town Hall Meeting Room. Members present were Tom Philippou and Lorin Johnson. Others present were Shanna Large (Clerk), Ira Grossman, R.S. (NABH), Debra Skauen-Hincliffe (221 Still River Road), and Kathy Bunnell (Harvard Press).

The Meeting was called to order at 6:00 p.m. Business was as follows:

**BOH Budget**

The Board reviewed the budget for 2008-2009. After a brief discussion the Board agreed to cut some costs with regard to office supplies but all other expenses must stay the same.

**MRC/MOU**

The Board reviewed the Medical Reserve Corp's Memo of Understanding (MOU). This document would allow other volunteers associated with the Worcester MRC to help in the Town of Harvard in case an emergency event occurred. Tom Philippou signed the MOU and it will be send to the Worcester MRC.

**Reverse 911**

Ira discussed with the Board the Reverse 911 system which is being offered currently free of charge for a year from the Worcester Sheriff's office. After a brief discussion the Board decided to contact the Sheriff's office and arrange for a meeting regarding the Reverse 911 system for the officials of the town.

**Pesticide Spraying**

The Board reviewed an email regarding the name of the pesticides applied to the school grounds in May 2007. After a brief discussion, a letter will be sent to the Harvard School Committee requesting the future application plans for the grounds and a copy of the license of the applicator. This letter will also be sent to Rich Nota at the Harvard DPW.

**Kavinsky, 70 Park Lane –**

Ira talked to the Board about the permit for the above property. There is a concern that the system is only 4 inches above the high ground water table. The permit is for two component replacements of a sewer line and leaching area line. These replacements would bring the system into Title 5 compliance. After a brief discussion the Board signed the permit.

## **Permits**

**Lisa Alder, 19 Blanchard Road** – Single component replacement for an existing dwelling. Installation of a Distribution Box.

**P&E Trust, South Shaker Road Map/Parcel 4/44** - Installation of a new four bedroom single family Subsurface Disposal System. 1500 Gallon septic tank and three trenches.

**Kavinsky, 70 Park Lane**- Component replacement for existing four bedroom dwelling. Installation of building sewer line and leach field line.

Tom Philippou made a motion to adjourn the meeting at 6:55 p.m. Lorin Johnson seconded the motion. The vote was 2-0 to approve.
