Variance request

A variance is required for percolation rates in excess of 40 minutes per inch. Fifty-eight minutes was observed. On behalf of the homeowners, Gary Shepard, engineer for this project, is requesting that the Board grant this variance. The Board unanimously agreed to grant the variance request.

Non-compliance, seasonal conversion

Ms. O'Brien shared an update from the homeowner's lawyer that the water quality testing has been complete (although no report on file) and process started with ZBA. The administrative assistant for the ZBA confirms no application has been filed. Mr. Grossman will compose a letter (and copy the building inspector) stating that no habitation shall occur once the summer season ends.

Update from Local Solutions: Northeast Climate Change Preparedness Conference
