The HCT needs a signed Purchase & Sales (P&S) from the Commission in order to receive funding. The P&S has been reviewed by Town Counsel and other then a few details, the documents look in good form to him. The members of the Commission feel there should be no issues with having a finalized document for their signatures at the September 4<sup>th</sup> meeting. The Commission will be receiving a 3.81 acre lot that will allow for continued access from the parcel at the rear of the property.

### Master Plan Steering Committee (MPSC) Update
