Debbie Ricci asked the committee if we should fund the dump truck out of capital funds as we have the funds for this.

The committee discussed what the best item would be to pay for including what the amount could/should be.

Roads may not need to be funded due to state funding coming forward.

There is a debt of \$162,000 in the Capital Fund that could be paid off.

The committee will discuss this further at the next meeting.

The committee suggested that the Science Labs might be the best items to place on Captial Exclusion this year and requested that we get a more accurate quote for the project. Pat Wenger agreed to work on this and bring the information to the next meeting,
