Minutes from the last 3 meetings were approved unanimously.

Robert introduced the idea of a Brochure describing HCTV The brochure would be used to communicate the goals and opportunities associated with HCTV **Action: Robert will provide content and a sample for the next meeting** 

Equipment:

The portable video rack in Cronin has been updated by Taylor. Work should be finished on Friday. It can be used for live and video taping. It may be used for the Central Mass Drama fest in March (if there are no copyright issues)

There is also work being performed on the audio equipment in Cronin. The plan is to update the equipment as necessary and the operation procedures should be documented.

A review of the 5 year plan activities focused on priorities and operations. We are tracking to the plan.

HCTV Hours Need to continue to publically inform the community of our open hours Monday and Wednesday 3-7 Saturday hours will be 9-11 (which is a 2 hour reduction)

Robert reported we are covering 18 meetings per month.

The committee has identified obsolete equipment. Action: Robert will identify the items in our inventory and find out if they can be sold

## Action Roberts will provide costs on lighting umbrellas and portable backgrounds

Robert may offer a Summer program for town persons interesting in learning how to use the equipment we have. He will provide more information next meeting.
