	Meeting Discussion/Status		
Minutes	The minutes of July 10, 2013 were approved 4-0.		
Membership	A motion was made to recommend to BOS to appoint Bill Codner as a voting member of HEAC. After a short discussion, HEAC voted 4-0 to recommend this appointment. Bill will be appointed at the next scheduled BOS meeting.		
Strategic and Capital Planning	 Goals - Brian stated that a list of goals for FY14 needs to be established and provided a previous version for review. There was no time in the meeting to discuss this further – all members to review outside of the meeting. The five year strategic and capital plan will be needed to submit in the Fall. A previous version was provided for review. The energy data total and breakdown by source were reviewed to determine target opportunities. The data did not include FY13 data which is being compiled. The FY15 CPIC Request applications are due 9/27. There were no large projects that stood out as capital requests to recommend. The goal is to come up with a list of recommended projects and energy savings and select projects from that list to recommend to CPIC. Ideas discussed, actions or projects to be funded as either capital or budget items: a. Energy Conservation Coordinator to focus on projects and behavior modification, especially in the schools. If the energy savings was 10% that would be enough to fund a \$50k position (Total Energy Costs for Town ~\$510k). Evaluate student assistance. b. Continuous Commissioning – this effort would confirm energy savings equipment is operating effectively on an ongoing basis. c. Schools – Weatherization, Lighting Controls. Also request Guardian to review both schools. Add equipment to BAS, especially in HES. d. Hildreth House – contact Guardian to review the building to see what projects could be initiated now in conjunction with the renovation. e. Pond Pump – this one pump uses more energy than the Hildreth House, Bromfield House and the Highway Dept in FY12. Verify it is on a VSD and find out what energy it draws when not operating and what the operating scheme is. f. New Library – the main opportunity other than the VSD project in process is Lighting Controls such as Occupancy sensors and integrated lighti
