## What is municipal aggregation?

Municipal aggregation is a form of **group purchasing** in which a city or town buys electricity on behalf of its residents and businesses.

## Key features:

- Customers can opt out at any time
- Aggregation covers only electricity supply. The utility is still responsible for electricity delivery, including billing and maintaining the poles and wires
- Applies to Basic Service customers



# Why aggregate?

Use the aggregated purchasing power of **1,900 Harvard** electricity customers (estimated) to create a choice that they do not currently have. (Estimated 17,000 MWH)

**Provides Price Stability** 

Is Consumer Friendly

Is Likely to be Less Expensive

Offers Optional Greener Energy



## One Case Study - Westborough

## A choice for a typical Westborough Resident that:

Fixed and level for two years

Supplier Committed /Consumers Not

3.8 cents less than utility winter rate

\$26/ month savings in winter

Expected to break even w summer rate

Expected savings > \$100 / yr / resident



## What does not change?

Customers continue to receive one bill from National Grid.

National Grid continues to restore service after an outage and to maintain the poles and wires.

Net metering remains the same.

Low income discounts remain the same.




