Master Plan Steering Committee Meeting Minutes January 28, 2014

The meeting was called to order by Joe Hutchinson at 7:10 PM

Minutes: Minutes of January 9, 2014 were approved as written.

<u>Meeting with Town Boards</u>: Two meetings with town boards have occurred: Joe H. and Jaye met with the Conservation Commission on January 16^{th} ; Victor and Lucy met with the Board of Selectmen on January 21^{st} .

If Elaine is unable to attend any of her meetings, Lucy will cover at MAHT, and SusanMary will cover at EDC. No one was identified to cover at Board of Health.

Members contacting boards were reminded to send "Conversations Town Boards" to the committees prior to their meeting with them. They were also reminded to select only one of questions #3 – 5 for discussion, based on the role/responsibility of the given board.

Stakeholder Conversations: Joe reported that Judi Barrett had interviewed 22 people (residents and town staff) in groups ranging from 2 to 4 people yesterday afternoon and this morning. After completing those interviews she was scheduled to meet with MassDevelopment staff this afternoon. According to Joe, Judi reportedly found considerable diversity of opinions on issues before the town. Victor and SusanMary were each interviewed. SusanMary felt there wasn't enough structure to the meeting; Victor noted that Judi commented to him that she was finding more dissention among residents than existed when she did the master plan in 2002. A copy of the interview schedule is attached.

<u>Communication:</u> Didi reported on activities to date and to be undertaken in the near future. He will be meeting with Leslie Bunnell, our web designer and manager, on Thursday or Friday, along with Joe. We discussed upcoming events that need to be posted on the website and advertised through a town wide mailing. These include the proposed round tables (on Housing, Conservation, the Town Center, and the C-District) and the March 8th public forum on Devens. After some discussion about available evenings for these round

table meetings, it was agreed that we cover two topics per round table meeting night, with $1\frac{1}{2}$ hours allocated per topic. The dates of February 25^{th} , February 27^{th} and March 11^{th} , from 6:30-9:30, were recommended to suggest to Judi. Once these dates are confirmed, we need to post them on our website, do the mailing and, perhaps, take an ad in the Harvard Press.

A link to our website has been placed on both the home page of the town's website and the Planning Board's page.

Didi asked that we provide him with group email lists we may have so that he can build a master email list for sending notices.

Didi reported that he and Joe Theriault had written another piece on the master plan process which had been submitted to the Harvard Press for publication in the next week or so.
