## Harvard Parks and Rec Meeting Agenda Minutes – 4/02/2012 Old Public Library 7:30 pm

- Approve minutes from last meeting.
   Minutes approved. Anne McWaters to send minutes to Janet Vellante.
- 2. Special topics
  - a. Presentation from UniBank for options to leverage town account for collection of registration fees.- Ryan Stolle UniBank
    - 12-13 years municipal experience. UniBank owns the software and can customize.
    - UniPayGold system schools, clerks, parks and rec, etc https.unipaygold.unibank.com
    - Allows for customizable front page (ex: Grafton Rec Commission), waivers, and registration pages.
    - Can pay using check, Discover, MasterCard credit and MasterCard debit. If we want Visa offered, we would need to up fees by about \$2. Credit card fees are currently about 2.5%. Get an email confirmation. If done by credit card, the process is done right away.
    - Town Hall would receive all payments directly. Refunds (if someone decides not to take a class) would have to be processed and issued through Town Hall.
    - Would not be useful to us in terms of registration, b/c we would lose the ability to mass email people signed up for certain classes.
    - League Athletics software is not compatible with UniPay so there would be a lot of manual labor to using this. Peak is another software that Rec departments can use and they do interface with UniPay (Stow just started using this). Switching to Peak would be heavily labor intensive as well though. League Athletics has some other options that we need to explore.
  - b. Discussion and possible vote on request for permit for slalom course on Bare Hill Pond. Jay Turchetta/Tim Turnbull
    - Proposing to form a waterski club gives them the ability to be insured by USA Waterski for sanctioned events. Anybody who participates with them becomes a "day member" (\$7 for such grass roots organizations) or "year member" and is covered. Would be willing to take the course down on the weekend. Parks and Rec would have to change the wording of Bare Hill Pond rules and add some verbiage about permanent buoys being allowed etc. Parks and Rec may not be in charge of changing the rules. The concern is about whether Parks and Rec would be "allowing" this course to be put in. Parks and Rec does not want that responsibility. The rules state that the Harbor Master is the one who has to permit. Next steps: Parks and Rec needs to find out how to get the rules changed and

then contact the Harbor Master and Town Council and confirm whether this proposal is allowable.

- New moorings the Helix anchor (helixmooring.com) is an option. Waiting back to hear price and installation cost. Lasts forever (is stainless steel) and is environmentally safe.
