## Town Hall Construction Committee 3/19/15 Meeting Minutes 7:30 a.m. at Town Hall

Members present: Laura Andrews, Bill Barton, Pablo Carbonell, Jack Guswa (by phone), Rick Maiore. Members absent: Al Combs. Others present: Tim Bragan (Town Admin. and Board of Selectmen liaison), Marie Sobalvarro (Assist. Town Admin.), Drayton Fair (LLB architect), Steve Kirby (Vertex Owners' Project Manager).

Rick called the meeting to order at 7:30 a.m. and the Committee approved the 2/23 and 3/17 minutes.

The three low construction bids are from G.V.W Inc. - \$2,253,135; M. O'Connor Contracting - \$2,317,700; and Mill City Construction - \$2,454,000. A complete chart of the bids is attached.

Drayton said that he would be reviewing the three low bidders at the Division of Capital Asset Management and Maintenance tomorrow. He will:

- Review each bid and request answers to questions on the Update Statement that are
  answered "yes." These questions are not a matter of public record, but the bidding
  company is required by law to provide statements to explain a "yes" answer to the
  awarding authority. Questions include matters of legal action, payment bond invocations,
  violations, and other information.
- Review evaluation statements from clients.
- Call references.

The Committee can turn down a low bid if it determines that the bid is non-responsive or the bidder is non-responsible.

Bill made and Laura seconded a motion for Drayton to act on behalf of the Committee to request answers to all Update Statement questions answered "yes" by 9 a.m. Monday, March 23. Passed unanimously by all members present.

Since only one of the bids was low enough to cover the two add alternates (windows and cupola), discussion followed about potential options. No decisions were made.

The Committee is on track to make its recommendation to the Board of Selectmen at 7 p.m. at its March 24 meeting.

The next THCC meeting will be at Town Hall, 7:30 a.m., Tuesday, March 24.

On a Pablo motion and a Jack second, Rick adjourned the meeting at 8:30 a.m.
