### **Public Comment**

Ames Hardymon, Old Boston Turnpike Road; Ms. Hardymon is a property owner in the District and was seeking clarification with regards to connecting when not a user of town water. Mr. Bragan explained that there needs to be a water meter installed and the town will issue a sewer bill, but not a water bill.

## Town Administrator's Report and Update

The Board of Health has prepared and will mail notification letters to the owner of the following District properties that need to immediately connect because they either have an I/A system or are in failure:

5 Pond Road; 36 Mass. Ave; 7 Mass. Ave; 5 Littleton Road; 13 Bolton Road; 7 Still River Road; 12 Oak Hill Road; 16 Ayer Road (this property is recommended, not required).

group following the approval of the Commission; so moved by Mr. Hedrick; seconded by Mr. Maiore; vote, aye, unanimous.

# **Issues Relating to Connection**

- Letter addressed to Fr. Kilcoyne of Holy Trinity Parish: Mr. Hedrick moved to accept letter as written; Mr. Maiore seconds; vote, aye, unanimous. Ms. O'Brien will mail it.
- ➤ Change in size hearing for UU Church, Fellowship Building, 7 Elm Street, is scheduled for Wednesday, May 29. 9 a.m.; Ms. O'Brien will notify church representatives.
- Update: Grease traps in homes; Mr. Maiore reported that due to the need for frequent and regular cleaning, installing grease traps in the homes of District properties is not recommended. However, if property owners wanted to have a garbage disposal it would like be a necessity to have a grease trap as well. Ms. Russo suggested checking with engineers to see if garbage disposals are a threat to system; Ms. Russo will ask Mr. Bragan to inquire with engineers.
- Ms. O'Brien inquired, on behalf of the Board of Health, about the Commission's recommendation for a suitable period of time in which to extend the connection waiver of the Harvard UU Church, as their current one is set to expire before their May 29<sup>th</sup> hearing. The Commission advises a duration of 90 days.

## **Other Matters**

The Commission will review the Finance Director's fiscal reports at the next meeting.

Mr. Maiore motioned to adjourn at 9:40 a.m.; Mr. Hedrick seconded; vote aye, unanimous.
