## VILLAGE OF HASTINGS-ON-HUDSON, NEW YORK BOARD OF TRUSTEES PUBLIC HEARING #1 JULY 15, 2008

A Public Hearing was held by the Board of Trustees on Tuesday, July 15, 2008 at 8:06 p.m. in the Meeting Room, Municipal Building, 7 Maple Avenue.

**PRESENT:** Mayor Wm. Lee Kinnally, Jr., Trustee Jeremiah Quinlan, Trustee Diggitt

McLaughlin, Trustee Danielle Goodman, Village Manager Francis A. Frobel, Village Attorney Marianne Stecich, and Village Clerk Susan Maggiotto.

**ABSENT:** Trustee Peter Swiderski

**CITIZENS:** Seven (7).

Mayor Kinnally declared the Board in session for the purpose of conducting a Public Hearing in accordance with the legal notice that appeared in the July 11, 2008 issue of *The Rivertowns Enterprise* to consider the advisability of adopting Proposed Local Law No. 25 Amending the Code of the Village of Hastings-on-Hudson Chapter 282 Vehicles and Traffic to Designate Certain New Parking Meter Locations as follows: south side of Main Street between the Hook and Ladder firehouse and the bus stop; north side of Main Street adjacent to 87 Main Street (A&P); north side of Main Street adjacent to new construction at 45 Main Street.

**Village Attorney Stecich:** The language reads between Warburton Avenue and the bus stop, and the notice reads between the hook and ladder and bus stop. They are both different.

**Village Manager Frobel:** Well, it is really redundant to say from Warburton along Main because we already have that authority. We are just looking to extend it.

**Mayor Kinnally:** It is less rather than more. It is between the hook and ladder and the bus stop.

**Village Attorney Stecich:** The language, however it was corrected on here, is wrong. Between the hook and ladder and the bus stop?

**Mayor Kinnally:** This being a public hearing, anyone wishing to speak in favor of or in opposition to the proposed local law, please come forward, give your name and address for the record.

**John Gonder, 153 James Street:** I am in favor of it. I just hope it is not a computerized system, and I hope it is for nickels, dimes, and quarters.

**Mayor Kinnally:** We are in receipt of an email from Kelly Topilnycky on this, which we will make part of the record. There being no further public comment, do I have a motion to close the hearing?

**Trustee Quinlan:** Before we close the hearing I want to clarify one thing. The north side of Main Street adjacent to 87 Main Street, the A&P, is this going to go from east of the bus stop up to the corner of Five Corners? Or is it in front of Citibank?

**Village Manager Frobel:** In front of Citibank, but also going up on the side where the A&P is, further up that side.

**Trustee Quinlan:** This is a public hearing and we will discuss it later, but I have concerns about going from the east side of the bus stop up to Five Corners. I would like to refer that to the Safety Council.

**Mayor Kinnally:** Can we do this at a regular meeting? We cannot refer it to the Safety Council at this public hearing.
