John Gonder, 153 James Street: I have a question in regard to the position of dog warden. I would like to know what takes its place. I have had a lot of problems with dogs, you know.

Mayor Kinnally: The duties have been taken over by the Town of Greenburgh.

Mr. Gonder: That is what I was afraid of. When you have a complaint and call the police here in Hastings they cannot act unless they see the dog running loose or people are not picking up. People that are accused of it run into their house. The police knock on the door or ring bells and they never answer. I understand you have Greenburgh, but there are a lot of people in our community that abide by the leash laws. In fact, you put a sign up by Pulver's Woods for me, which was nice. But other people do not give a darn.

I was wondering how you can take care of those people who leave their dogs run loose. I have grandchildren that are allergic to dog hair. I also have grandchildren that are afraid of dogs. There is not much you can do with it, and yet some of my neighbors let them run loose. So I think you need someone. It could be a position that is filled by an independent person that you swear in and give them the duties of issuing a summons to these people.

Mayor Kinnally: Thank you. Anyone else to speak either in favor of, or in opposition to, the proposed local laws?

Hearing no further comment, Mayor Kinnally asked for a resolution to close the Public Hearing.
