**Trustee Quinlan:** We have quite a busy night December 2, so I was thinking about putting on these proposals for action on December 16. I do not know how everyone feels about that, but I think it would be a good idea. It would give a little bit more time for written comments.

**Mayor Kinnally:** How long do you need to put comments in?

**Ms. Mauch:** Ten days is typical. We just received these today, so we have not had time to look at them.

**Mayor Kinnally:** All right. Ten days would be the Friday after Thanksgiving. Or the Monday after Thanksgiving, why do we not do that, December 1.
