#### VILLAGE MANAGER'S REPORT

**Village Manager Hess:** Raf has informed me that our e-mail list is up to 261 people signed up to get information from the Village.

Last weeks's snowstorm: the Public Works Department did an excellent job in getting the roads clear.

We were notified by Westchester County that we will receive \$25,000 for Riverview Park, one of the items we applied for under the three-year grant proposal that was turned down. They have additional money and have granted us that money for 2001. The county will be doing the design. These funds will be used in the lower area. At least half will probably be used for handicapped accessibility.

Mayor Kinnally: I would like to second what you said about the excellent snow removal. Sixteen inches of snow is a heck of a snowfall. We were lucky it came when it did, and on the weekend, but it was difficult for the DPW, nonetheless, because it was a holiday weekend. I would like to thank Mike Gunther and all the men of the DPW for what they did over that holiday period.

I would like to note, and congratulate, Riverview Manor Hose Company Number 3 on their 90th anniversary of serving this community.

#### **BOARD DISCUSSION AND COMMENTS**

### 1. Update on the Waterfront

**Mayor Kinnally:** We are in receipt of a notification from the DEC on various developments that have occurred over the last few months on the waterfront: the reconstruction of the bulkhead, the demolition of a number of buildings, and some of the testing results that have been received and are being analyzed at the present time.

#### 2. Other

**Trustee Jennings:** I would like to add one thing about the snow removal which impressed me, that is, not only the job immediately at the time of the storm but the two or three days following: the cleanup to get the snow off the edges of the street making it easier to turn corners and so forth. The follow-up work is excellent, and just as important as the first plowing, and I commend the department for doing that as well, because it has made the last couple of weeks much easier for all of us.

**Village Manager Hess:** The cleanup takes more time than the plowing operations because we have to work around parked vehicles, parking lots, the two alternate cleaning days either Monday nights or Thursday nights, etc. So it takes awhile. It will be about a week and a half, especially with a storm as significant as this was.

**Trustee Holdstein:** I am concerned about the ice in the train parking lot.

**Village Manager Hess:** There is alternate parking and apartment people park in those spots overnight. It is going to be warming up in the next couple of days, but I will have to send out a truck with salt on it, because all we were using was the loader for cleanup.

#### **EXECUTIVE SESSION**

On MOTION of Trustee Walrath, SECONDED by Trustee Jennings with a voice vote of all in favor, the Board scheduled an Executive Session immediately following the Regular Meeting for discussion with counsel on litigation and discussion on land acquisition and personnel.
