VILLAGE MANAGER'S REPORT

Village Manager Hess: Village internships are again available to high school and college students in all departments of the Village for 15-20 hours per week or full time in the summer. Interested students should contact Village Hall in person or through e-mail.

We have hired a new building inspector, Joe Hernandez, a building code enforcement officer in White Plains since 1997; prior to that he served with the New York City housing authority for 12 years in various construction and inspection positions, and was superintendent of construction for the New York City health and hospital corporation for four years. Joe brings an outstanding combination of knowledge, experience, and technical ability to the position and I am pleased he has agreed to join the Village staff. He holds certifications in the New York State building code as well as certification in asbestos abatement and hazardous materials.

We are announcing the promotion of Michael Gunther to head the Department of Public Works; he has been Acting Superintendent since Marco Gennarelli left in November. He has been Assistant Superintendent since 1996 and has been employed in the department since 1983. He was the top candidate among the 35 from the northeast who applied for the position. He brings an outstanding combination of knowledge, experience, leadership ability, and caring about our community and its residents. I believe he will be a great addition to our management team.
