1. Update on the Waterfront

Mayor Kinnally: There were several meetings yesterday. I met with Sandy Stash of BPAmoco and we discussed the possible removal of buildings on the waterfront, the state of building 15, the rip rap and bulkhead, the Riverkeeper lawsuit, and progress with DEC. I had a conference call on the Riverkeeper lawsuit settlement negotiations with our counsel Mark Chertok, counsel for the Riverkeeper and BPAmoco, and our engineering consultant firm in the lawsuit, Malcolm Pirnie. Last night Mr. Hess, Mr. Chertok, Warren Riznychok from Malcolm Pirnie, and I met with DEC. I will share information from that meeting in an Executive Session with the Board.

EXECUTIVE SESSION

On MOTION of Trustee Jennings, SECONDED by Trustee Holdstein with a voice vote of all in favor, the Board scheduled an Executive Session immediately following the Regular Meeting to discuss litigation and personnel.

Mayor Kinnally: I have a letter from the Hudson River Valley Greenway congratulating us on being awarded a \$10,000 matching grant to hire a consultant to undertake a study to determine the most appropriate means of implementing the Village's waterfront plan. Congratulations to Neil, Meg, and the members of the LWRP.
