They were absolutely astounded at the support of the people in the community when they came out and gave the Village Board the support to say that we want to acquire this. I think that broke the logjam. The problem was not in Rockland County but with the other owner in Florida. But is a nice ending to it, and I am really overwhelmed by it. Thank you very much.
