INVOCATION

Rev Andrew Jagow of St. Matthew's Lutheran Church delivered the invocation.

Mayor Kinnally: This is Trustee Gagliardi's last meeting, and it is always tough to say goodbye. When Tony came on board two years ago I had known him from his and his family's activities in town and on the Fire Department. If anyone defined what a team player was, and worked with his colleagues to try to reach a consensus in many difficult decisions, it was Tony. As I worked with him over the past two years I was reminded of someone else who had served on the Board., Ed Murray. Ed served for six years and when he was first elected he said to me, "I may not say very much in the beginning because I just want to sit here and learn." He learned and really did an exceptional job as a Trustee. Tony did the same thing. When Tony spoke up it was because he had something to say. I am reminded of when we were dealing with whether to settle the certiorari proceeding with the owners of the waterfront. He listened; he said his piece in private, not always agreeing with us, raising a number of interesting questions, and making us think through the whole thing. It is the policy of the Board of Trustees of the Village of Hastings-on-Hudson to conduct Village business in an open fashion and to make available as much information as may legally and practically be disseminated.

The New York Open Meetings Law authorizes the Board to conduct business in executive session in a number of areas. These include:

- 1. matters which will imperil the public safety if disclosed;
- 2. matters which may disclose the identity of a law enforcement agent or informer;
- 3. information relating to criminal investigations;
- 4. discussions relating to proposed, pending or current litigation;
- 5. collective bargaining negotiations;

- 6. personnel matters; and
- 7. the proposed acquisition, sale or lease of real property or securities.

The Board recognizes that it is authorized to use executive sessions in these situations, but will do so with restraint.

To maintain confidentiality and to encourage the uninhibited discussion of the subject(s) of executive sessions, the specific subject matter and any statements made or positions taken by all participants must remain confidential and may not be disclosed by any participant unless and until a majority of the Board votes to authorize the release thereof by the Board.

It has been and continues to be the practice of the Board that all members of the Board, acting together, come to agreement by consensus on the specific information which is to be released to the public, the suitable vehicle for reporting that information, and the timing of the reporting.

On MOTION of Trustee DeVita, SECONDED by Trustee Keaney with a voice vote of all in favor, the Board scheduled an Executive Session for Tuesday, April 13, 1999, following the Public Hearing on the budget and work session to discuss personnel items.

VILLAGE MANAGER'S REPORT

Village Manager Hess: Hastings 1999 is sponsoring a volunteer organization recognition day at the Community Center on April 18, and there will be an auction at the Southside Club, sponsored by St. Stanislaus on April 24. Hastings 1999 is also sponsoring a Village-wide tag sale at the train station on June 19.

The budget hearing is April 13. We encourage everybody to make their feelings known to the Board about the proposed 1999-2000 budget.

We are losing two very good members of our recreation staff. Dana Mayclim has gone to the Town of Lewisboro as a recreation leader, and Anthony Giaccio, assistant superintendent of recreation, has accepted a position as superintendent of recreation with the Village of Dobbs Ferry. Anthony has been an outstanding employee for the Village and has done a wonderful job at the pool, and Dobbs Ferry is getting an outstanding person. We wish Anthony and Dana well.

BOARD DISCUSSION AND COMMENTS

1. Update on the Waterfront

Mayor Kinnally: BP/AMOCO has announced that they are acquiring ARCO, so we will have a new set of players to deal with. Indications are that the head of BP is very bottom line-conscious. I do not see him throwing any more money at this site than ARCO was going to do, and that was little indeed. I think we are in for a long fight with BP.

I am meeting with DEC Commissioner Cahill to discuss the most recent developments. We will also meet with Malcolm Pirnie and with our environmental counsel. There may be a shrinkage of the ARCO force on the West Coast, and I do not know what presence BP has in the United States or if they have an environmental component to it. Nothing is likely to happen over the next six months. I am very concerned about this, and we will try to determine how to proceed.

Trustee Holdstein: Do you think everything will freeze for six months in terms of moving forward: the DEC, PRAP's, ARCO, bulkheads, etc?

Mayor Kinnally: I do not think the DEC is going to allow that just to stay the way it is. The sampling will go forward. I have received commitments that they were going to go forward with the environmental assessment of the buildings and that they would be coming up with some design for tearing down some of the derelict buildings. The six-month reference was to the restructuring of ARCO.

Trustee Keaney: I think I share your concern about the BP takeover. The fear is that they may view Hastings-on-Hudson as very small potatoes and not be interested in living up to what ARCO has said they were going to do. That is the danger, but there is an opportunity here also. They have to get regulatory approval to do this. This is an avenue for us to make a position to the antitrust authorities. We might ask for making it a condition of the merger that they live up to their environmental responsibilities or to what ARCO said they wanted to do. This will at least get a response from BP in a public hearing.

The pitch should be that the Hudson River has just been designated as an American Heritage River and it has the most PCB's in New York State. Do you really want a foreign corporation owning this in this state of dilapidation without adequate safeguards for cleaning up? I am not saying we could stop the merger, but I am asking for a recognition by those authorities that we need help in getting them to live up to their safety responsibility. They may also have other sites throughout the country where they are remiss.

Mayor Kinnally: We should reach out to John Cronin and Scenic Hudson, and coordinate with the Conservation Commission and the LWRP to make sure we will be heard.

Trustee Keaney: We should also contact Congressman Gilman because we are talking about a federal agency, and he is very conscious about the Hudson Valley.

Mayor Kinnally: I am in receipt of a letter from Malcolm Pirnie confirming discussions about their providing supplemental sampling work for us in connection with the plan that is being generated by ARCO with the DEC.

Trustee Walrath: Will we have comments on the proposed additional samplings?

Mayor Kinnally: I am sure we will. I have to find out where Malcolm Pirnie is on it, and if Pirnie needs more time we will give them time. It was everybody's understanding that there would be a joint effort.

2. Other

Mayor Kinnally: Let met talk briefly about my visit to Hastings, England. It is a seaside area with a rocky coast and a population of 80,000. Parts of it are very beautiful. I met with Godfrey Daniel, the Mayor of Hastings for about an hour. There is a 34-person council with the Mayor elected by the council. We exchanged some gifts. There is some tourism, but all of the seaside areas have lost tourism because of the inexpensive airfares to the continent. It is an hour by car from Hastings to the tunnel at Dover, and you can be in France by car in a couple of hours after that on the train. Hastings from London by train is about an hour and 20 minutes. We could not get a car there, so we took a train from Dover and drove over to Hastings.

Finally, Charlie Hoffman is retiring this evening as chief of the department. He has served 16 years, and I would like to thank him for all of his work. It is not easy being chief and their

commitment, eight-year terms, is often tough, and he has gone around twice, just like his father, in serving so long, but my congratulations.
