SCHOOL DEPARTMENT - SCHOOL REPAIR WARRANT ARTICLES:

Present: Joseph Baeta, School Superintendent

School Committee members:

Mr. Baeta reviewed five town meeting warrant articles, approved for submission by the School Committee, requesting a total of \$495,000 of funding for repairs to the schools. The Superintendent explained that there is particular concern about the school roofs, and the parking lots are in poor condition. The roof at the Kennedy School is the worst, and an insurance claim is pending. The South School roof has a leak, and the Junior-Senior High School's roof is in bad condition. The parking lot at the Junior-Senior High is the worst, with the South School second. It was reported that there is an air flow problem in the ventilation systems at the schools, especially the South School, which could lead to a mold problem, followed by an air quality issue. The boiler at the Junior-Senior High needs repair. It was discussed that the Capital Improvement Fund does not have enough available funding for these requests at this time. Mr. McGaughey suggested that the Town speak to Rep. Ronald Mariano. Mr. Baeta advised that if a new building is built, \$1 million could be added to the cost and set aside for the purpose of funding similar capital maintenance costs in the future. Doing so, would qualify the town to receive 1% more in reimbursement.

TOWN ADMINISTRATOR SEARCH ADVISORY COMMITTEE:

The Chairman explained that Town Administrator Michael Yunits has accepted the Town Manager's position in the Town of Norton. He suggested that a 5-member committee be established to weed through the applications for the position and come back to the Board of Selectmen with recommendations on finalists who will be interviewed by the Selectmen. Mr. Moore indicated that the committee should include a member of the Board of Selectmen, the Finance Committee, the School Committee, and two members of the community, preferably with a human resource or recruiting background.

BUILDING INSPECTOR'S CERTIFICATION:

Present: David DeLuca, Esq., Murphy, Hesse, Toomey & Lehane (Town Counsel)

Mr. Moore explained that Building Inspector Richard Monahan is currently out of state, but a letter has been received from the Commonwealth of Massachusetts regarding Mr. Monahan's status as a Building Code Enforcement Official. When Mr. Monahan was appointed, he had 18 months to become certified, and he has failed to complete that process.

Attorney DeLuca said that MGL Ch. 143 § 3 mandates the minimum qualifications required for this position, and that Mr. Monahan's appointment has been a conditional appointment, limited to the 18 months allowed to take the exams. Mr. Monahan did not take the opportunity to take the exams, and requested an extension of time, which the Mass. Board of Building Regulations and Standards denied. Mr. DeLuca went on to say that Mr. Monahan has requested an appeal of that decision, but the Town does not have a certified building inspector.

Discussion took place about appointing an interim building inspector. The Board discussed appointing former Building Commissioner Daniel Moriarty, Jr., who is fully qualified.
