 Volunteers are needed to help clean up the streets and public areas in town. A free cookout will be held at noon at the Sumner Field. Chairman Gordon recognized Selectman Sheehan for his hard work in preparation for the day.
- The Memorial Day Parade will be held on Monday, May 28, 2012, and will commence from the Junior-Senior High School at 10:00 am. Following ceremonies in Mary Wales Holbrook Park, the parade will continue to the Union Cemetery. The morning will begin with a ceremony at 8:30 am at Wendell Cemetery on South Franklin Street in Brookville. All veterans were encouraged to participate.

Mrs. Hathaway explained that the book drop has been repaired multiple times, and is now rusted out. Books left in the drop have been ruined, and have to be replaced. A new book drop is estimated at \$4,500 - \$5,500, and would also provide a place for the safe return of CD's and DVD's.

The hearing notice published in the *Holbrook Sun* on May 4, 2012 was read. Mr. Bass introduced himself and spoke briefly about his plans. Mr. Bass indicated that he did not notify the abutters by certified mail as required. It was discussed that the hearing could be continued to a future meeting to allow for the proper notification of abutters. A letter from the Board of Selectmen will be sent to Mr. Bass that will be enclosed in the envelopes to the abutters to explain the continuation of the hearing.

TOWN SCHOLARSHIPS:

David Dingledy, the Chairman of the Town Scholarship Committee explained that because of the generous donations received this year, Town Scholarships, in the amount of \$1,000 each, are being presented to seven deserving students. The water bills, which are sent out twice a year, include one quarter with an actual reading and one quarter that is estimated.
