TOWN ADMINISTRATOR'S REPORT:

Mr. Phelan reported that there was a meeting with the Mass. School Building Authority (MSBA) relative to a SCHOOL BUILDING PROJECT in Holbrook, and the MSBA voted to move Holbrook on to the next phase in the process. Mr. Phelan explained that the Selectmen voted on the enrollment certification required by the MSBA, and now must vote to authorize the Chairman to sign the feasibility study agreement.

Richard Reuss, the Emergency Management Director, has been notified that he has been awarded a GRANT for the procurement of portable radios by the Massachusetts Emergency Management Agency (MEMA). This grant does not require a funding match by the town because volunteer hours were used.

Mr. Sheehan mentioned that Mr. Reuss had the Emergency Operations Center (EOC) open on Saturday during the Fire Department Open House so that residents could tour the facility, and he did a great job.

Benjamin Ecord, the Public Works Supervisor, requested that the Board of Selectmen approve his recommendation to hire DANIEL MULRY for the position of Craftsman/Laborer II in the Public Works Department. Mr. Ecord spoke highly of Mr. Mulry's qualifications and dedication.

Atty. Coleman said that there will be no substantial changes to the current operation. They may try Karaoke on Fridays and Saturdays, but are not sure whether it will work. They have requested the same licenses currently held at that location, with no changes.

Mr. Kevin Lacey, 140 West Division Street, Braintree, said that Karaoke can be loud when the doors are left open to the restaurant. He asked that the doors be closed when there is Karaoke, and Atty. Coleman indicated that could be done.

Marylou Hall of West Division Street expressed a concern about the pool table. She mentioned that there were issues at the plaza when the billiards hall was there. It was explained that the license is only for one pool table, and the current owners are licensed for one pool table at the restaurant now.

Mr. Galante introduced his clients, and explained that Mr. Dang has a degree in engineering and has worked with his father in a liquor store for seven years, while Ms. Hguyen has operated her own nail salon for 13 years. It was discussed that the applicants may close the store a couple of hours earlier than they will be licensed for. Otherwise, there are no changes to the operation.

MOTION: By Mr. Fuller, second by Mr. Sheehan, to approve the transfer of the Retail Package

Store License to Expose, Keep for Sale, and to Sell Alcoholic Beverages Not to be Drunk on the Premises from Mary Day Le dba Holbrook Liquors (Mary Day Le, Manager) to Hai Dang and Ha Nguyen dba Holbrook Liquors (Hai Dang, Manger) at 4 South Franklin

Street

VOTE: 3:0:1 (Mr. McGaughey abstained)

Mr. Gordon explained that the materials necessary for an ELECTRICAL SERVICE CHANGE at the SUMNER FIELD have been purchased, and Mr. Paul Barker has been contacted about completing the work. Mr. Barker was present and said he met with Mr. Dowd, who ordered the stock. He feels that with the Holbrook Wiring Inspector, Alfred Osward, and Mr. Donald Young from Randolph, the job can be completed.

Mr. Barker explained that there is currently 40 amps feeding the Public Works shed and the concession stand. This work would upgrade the electric service to one big circuit breaker box. Mr. Dowd purchased everything he could think of, but there could be another \$5,000 needed to complete the job. The Public Works Department will dig the 225-foot trench that is needed. The power will be off at the field for 7 to 10 days. The job includes piping up a pole and installing three lights between the buildings. It was discussed that there is a dark area where young people congregate, and that area should be lighted for security purposes. Installing a telephone pole is approximately \$600, plus the pole.

Mr. Ecord announced that the RE-PAVING OF ROUTE 139, PLYMOUTH STREET AND ABINGTON AVENUE, from Belcher Street to the Legion Post, will begin on October 15, 2012, and could take 60 days. The crosswalks will have concrete areas and the sidewalks will be completed also. Signs alerting the public about the start of the project have been placed at Walgreen's and Hallamore's. Mr. Phelan said a preconstruction meeting was held that was very productive. The Superintendent of Schools made a suggestion for temporary crosswalks, and is sending leaflets home to the parents. A reverse 9-1-1 call will be made to homeowners.

A "Welcome to Holbrook" sign will be installed near Centre Street, on the fence, and another will be installed at a location on Sycamore Street where the water ban sign is now. A sign will be ordered for the Historical Society's Little Red Schoolhouse on Union Street.

Mr. McGaughey said that Mr. THOMAS CUMMINGS, who has been hospitalized, is home and doing well.

Kevin Costa, Chairman of the Town Government Study Committee (TGSC), explained that they recently met with about a third of the town meeting members, reviewed the DRAFT CHARTER, and received good feedback. The TGSC will have a meeting next week when they will discuss everything and try to come to a final resolution. Mr. Phelan said it is important that the Board of Selectmen has a chance to vote on the issues they raised and make sure their votes are taken into consideration before a final document is voted on by the TGSC. Mr. McGaughey said that the final version should then be presented to the Selectmen and voted on by the Board. Mr. Costa indicated the TGSC would try to come to a resolution and come back to the Selectmen in order to come up with a final document that will not be amended at town meeting.

The Town Clerk, Moderator and School Department will be contacted about a SPECIAL TOWN MEETING on either January 15, 16, or 23, 2013.
