Mr. O'Brien reported that:

- o The Local Cultural Council is sponsoring a Family Concert Night at the Gazebo on July 26th from 6 − 7:30 pm. Colm O'Brien, an Irish singer, songwriter and balladeer will perform.
- o The Tri-Town reservoir is at 96.3% capacity.
- o The Metropolitan Area Planning Council (MAPC) offers services to assist the town with the surrounding community designation and mitigation related to the potential Brockton casino.
- A tour of the former school at 227 Plymouth Street was conducted with representatives of Agape Inn. An engineer will be brought in to examine the building. The Board supported them going in the building with a representative of the Town present.
- A zoning issue concerning neighbors reporting each other will be handled by the Building Inspector/Zoning Enforcement Officer.

POLICE CHIEF APPOINTMENT:

Mr. O'Brien explained that Sergeant/Acting Chief William Smith scored first on the sole assessment eligibility list generated by BadgeQuest and the Human Resources Division (HRD), after taking into account his experience, education and scoring from the assessment center. The 17 day appeals period has now expired, and there have been no appeals. Mr. O'Brien has discussed the parameters of an employment agreement with Sergeant/Acting Chief Smith, and asked that the Board reaffirm his appointment as Chief.

The Planning Board members left the meeting.

Mr. O'Brien explained that he met with the MULLINS COMPANY to discuss the status of developing the property on Union Street where the bowling alley is located. They offered nothing definitive. Mr. O'Brien mentioned the need for over-55 housing and a supermarket in Holbrook.

The Town's solid waste contract with Republic Services expired on June 30th. There is a meeting next week to work on coming to an agreement.

Treasurer/Collector Paul Digirolamo reviewed the results of the recent tax title property auction. Two parcels were sold at minimum bid prices, and three abutters offered bids that are less than the minimum prices. Mr. Digirolamo said that because he postponed the auction, he can re-post the properties for sale and take offers after making sure no one else is interested. Mr. Moore asked that he speak to the Building Inspector about the values.
