# Minutes of the Regular Session of

The meeting was called to order at 7:00 p.m. by Chairman Moore, in the Selectman Noel C. King Meeting Room, Holbrook Town Hall, Floor 3R, 50 North Franklin Street, Holbrook, MA 02343, and began with the Pledge of Allegiance.

# Mr. O'Brien reported that:

- o A report of a rooming house at 115 Union Street has been referred to Inspectional Services.
- $\circ$  The Board of Assessors is currently working on the triennial certification for this fiscal year, based on housing sales during 2014. They expect an increase in property values of 3% 5%.
- Fire Chief McFadden has reported that the Department will be receiving a grant of Narcan, which is used by first responders in overdose situations.
- o Holbrook Cares will be holding an overdose vigil in Mary Wales Holbrook Park. They have been asked to contact the Public Works Department relative to the use of the Park.

Mr. Moore announced that the American Legion Post will be conducting a ceremony this Sunday, related to the War on Terror. A section of steel from the World Trade Center in New York, which was attacked on September 11, 2001, will be made part of a memorial on the front lawn of the Post on Plymouth Street. Tickets to the reception are \$25 each, with proceeds going to the construction of the memorial.

PROMOTION of POLICE OFFICER THOMAS GAINEY to the position of Full-Time Permanent Sergeant for the Town of Holbrook Police Department – Officer Gainey and members of his family were present. Police Chief Smith introduced Officer Gainey.

Town Clerk Jeanmarie Tarara swore Sgt. Gainey in to his new position. Sgt. Gainey was congratulated by all.

Firefighter Brian Macauley updated the Board on the CAR SHOW event to benefit Muscular Dystrophy, which the Firefighters are conducting on Saturday, August 15<sup>th</sup>, at the Sumner Field. The interest and support of the event was described as overwhelming. All are invited to this free event.

Town Treasurer/Collector Paul Digirolamo introduced Margaret MacLean, the Vice-President of Unibank Financial Advisory Services, who is the Town's Financial Advisor, and was present to discuss the funding of the new PreK – 12 School Project. She explained that the money borrowed must be spent within two years, and it is anticipated that borrowing will begin in the first quarter of 2016. Payments would begin on the money that is borrowed, and 10% of the money borrowed would have to be spent within 6 months; 45% within 12 months; 75% within 18 months; and all of the money within 2 years. The Town's share of the project is \$47 million.

Terry Grady, the Municipal Services Manager of REPUBLIC SERVICES, the Town's trash contractor, was present about a renewal agreement for the collection and disposal of the Town residents' trash and recycling. Mr. O'Brien explained the terms of the new agreement. The contract can be terminated at any time, in case the new transfer station comes online. Mr. Ecord said that there will be roll off dumpsters at the Compound on Maple Street under the terms of the new contract. Town Counsel is currently reviewing the contract.

Ms. Mariva Veiga was present asking for a PERMIT TO SOLICIT on behalf of Comcast/Xfinity. Mr. Moore read the door-to-door soliciting by-law, and explained that the Town's experience with door-to-door canvassing has not been good. The citizens have indicated that they are appreciative that the Board has not been allowing it. He explained that the Board has suggested that companies find other ways, other than going door-to-door to residences.

Mr. O'Brien reported that about 30 applications have been received for the Town Administrator's positon. The Search Committee will begin its work next week.
