SURROUNDING COMMUNITY DESIGNATION – BROCKTON CASINO:

Mr. O'Brien explained that Attorney Silverstein of Kopelman and Paige, PC, has been working with members of the Surrounding Community Negotiating Team relative to mitigating the potential impact of the proposed casino to be located in Brockton. The Town has now been notified that it has been designated as a Surrounding Community by Mass Gaming & Entertainment, LLC, and is listed in its RFA-2 application to the Mass. Gaming Commission. The Town must now assent to the designation.

MOTION: By Mr. Moriarty, second by Mr. Sheehan, to authorize the Chairman of the Board of Selectmen to execute a letter to the Massachusetts Gaming Commission assenting to the designation of the Town of Holbrook as a Surrounding Community for a proposed Category 1 gaming establishment in Brockton, Massachusetts
