# Minutes of the Regular Session of

The meeting was called to order at 7:00 p.m. by Chairman Moore, in the Selectman Noel C. King Meeting Room, Holbrook Town Hall, Floor 3R, 50 North Franklin Street, Holbrook, MA 02343, and began with the Pledge of Allegiance.

Town Administrator Timothy Gordon reported that:

- o New, unwrapped toys can be dropped off at the Fire Department for Toys for Tots until Dec. 18
- o There is a vacancy in a Citizen at Large position on the Permanent School Building Committee
- o Holbrook Jr. Sr. High has been designated a Level 1 school by the Dept. of Elementary and Secondary Education, based on MCAS scores. The South and JFK Schools are Level 2.
- o The Financial Departments have been busy with preparing for setting the tax rate
- o An agreement has been reached with Patriot Energy for the Town's electric power at a rate of 8.29 cents per kWh. The Town's current rate is 10.58 cents per kWh.
- There will be a meeting with the tax title attorney next week.
- There is an upcoming meeting with Atty. Jim Lampke, the Town's counsel in the Norfolk County Agricultural School litigation, relative to the prior years of school tuition.
- o There will be a meeting scheduled to discuss the special water audit that was done a year ago.
- The Capital Improvement Planning Committee will be meeting to discuss the capital items requested for FY17.
- o Negotiations are continuing with the Joint Water and Dispatch unions.
- The slogan contest closes on the 15<sup>th</sup>.
- The Planning Board has been meeting with Verizon about extending a tower. Verizon said they will not be putting up a new building. Instead, they will use small cabinets for the equipment and use landscaping around them.
- o The School Committee is discussing creating a new maintenance committee.

The AMORTIZATION of the SNOW and ICE DEFICIT, due to the unprecedented amount of snow during the winter of 2014 - 2015, was discussed and voted in advance of the tax classification hearing

this evening. The Town is allowed to amortize the deficit over a 3-year period. During the discussion, it was agreed that it should only be spread out over two years at the most. The anticipated federal reimbursement was taken into consideration.

Mr. Harring reviewed the packet of information he presented to the Board of Selectmen. The property values, following the revaluation of all property this fiscal year, and the Town's new growth, were approved by the Dept. of Revenue (DOR). Sales from 2014 are used for the property values. It was noted that the numbers being discussed are preliminary until they are certified by the DOR. Mr. Harring explained the effect of changing the "shift", which is the factor used in allocating the tax levy between

the residential, commercial, industrial and personal property classes. He indicated that the Board of Assessors recommended that the shift remain at 1.69.

Mr. Harring explained that the Board of Assessors is working to combine small lots in order to cut the number of properties and make it easier for the taxpayer and the Assessors.

Kevin Costa, Chairman of the Finance Committee, recommended shifting toward the commercial properties and making the tax increase percentage equal for both residential and commercial. Board members explained that the Town needs to be business friendly in order to attract businesses, not further burden the current businesses. Mr. Harring said the only new growth in commercial/industrial properties was the infrastructure for the electric company.

Wayne Darragh, Vice-President of Community Opportunities Group, Inc., was present to speak about applying for an FY16 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG). He explained the significant change in the rating system used now for CDBG grant applications. Holbrook's needs score has dropped to 26 out of 35, which is now a competitive score. He suggested that Holbrook submit a joint application for housing rehabilitation with the Town of Rockland. Holbrook would be the lead town, and Rockland would declare itself as CDF2. Rockland would be limited to \$350,000. The application would also include at least one social service activity, which could be supporting a food pantry, activities or outreach workers for the Council on Aging, or fuel assistance, among other options. Mr. Darragh will also check to see if grant funds could be used for fighting the current opioid drug addiction issue in Holbrook. Following discussion, Mr. Moore indicated the support of the Board for a joint application for a grant with the Town of Rockland for housing rehabilitation and other options that will be decided at a meeting in January.

Chief Smith submitted a request that RETIRED SGT. WILLIAM KEEGAN be appointed as a Special Police Officer in accordance with a provision in the Union contract.

Chief Smith reported that an additional cruiser is being funded by a grant for traffic stops; officers are being trained on using LoJack for dementia patients; a program has been started at the Police Dept. to watch homes when residents are away.

Supt. Ecord thanked Mr. Dennis Barry for the use of the trailer for the Annual Festival of Lights, and Mr. John West for the use of a crane to hang the lights on the trees. Mr. Moore said the attendance was twice the usual this year, which was the first year of holding the celebration on a Saturday evening. Treasurer/Collector Digirolamo said that the water bills are due Monday, liens will go on in February, and the demands are going out.

Chief McFadden reported that a donation of Narcan has been received with the assistance of Sen. John Keenan. There were 83 saved lives this year.

Communications Director Stephan Hooke reported that he has been talking with the Town of Canton, which would be a year away and contingent on a 911 development grant. Additional full-time staff would be needed to handle dispatch for another town. He has been working on rate increases with the Town of Sharon, and will be working on a cost model for Abington.
