## Town Administrator's Report:

- o Mass. Highway will be doing sidewalk improvements on N. Franklin St.
- o Al Osward, the Wiring Inspector for the past 12 years, is resigning from the position.
- o The Laurel Park water improvements are complete.
- The Inspectional Services Code Enforcement Policy is complete and ready to be voted by the Selectmen.
- The contract for the new accounting software, Soft Right, is being processed. The Town will begin using it in July 2017, as the new fiscal year begins.
- The Orders of Taking will be voted tonight for the street acceptances voted at town meeting in May.
- He met with D'Ambrosio and Brown about auctioning properties.
- o The Dept. of Revenue still owes the Town a report on our policies and procedures. The one on the financial management structure has been received.
- o The water/sewer rates will need to be raised at an upcoming meeting.
- o The Division of Local Services will be working with the Town to complete the Tax Recap and set the tax rates.

- The Twinbrook Insurance building area is going through hearings looking for approval to be converted to nineteen condos.
- o Chief Smith spoke about a municipal certification program for Police Departments.

Recently, two members of the TOWN FOREST COMMITTEE resigned. One resident, Heather McLellan, has expressed an interest in an appointment. Mrs. McLellan was present and introduced herself.

The request for a Change of Manager and Change of DBA on the All Alcohol Restaurant License in the name of Halfway Cafe, Inc. dba Lucky Lou Lou's, 200 South Franklin Street, was postponed to the next meeting.

A representative of the SENDHI CORP. dba HOLBROOK FOOD MART was present requesting a change in the hours they are allowed to sell alcohol under their All Alcohol Package Store License. The license that was just transferred to them allows a 9 am opening Monday through Saturday. Their prior wine and malt beverages license allowed an 8 am opening. They requested a 6 am opening Monday through Saturday. Discussion took place that the earliest opening legally allowed is 8 am.

MOTION: By Mr. Lee, second by Mr. Moriarty, that the Board of Selectmen approve with

modification, the request of the Sendhi Corp. dba Holbrook Food Mart, to amend the approved hours on its All Alcohol Package Store License by allowing the sale of alcohol from 8:00 am until 11:00 pm, Monday through Saturday, and from 10:00 am until 11:00

pm on Sundays, and that the application be sent to the ABCC for consideration

Paul Anastasio was present representing the BUILDING ASSOCIATION of the WILLIAM B. DALTON POST 137 AMERICAN LEGION, INC. relative to an application for a Change of DBA to Liberty Publik House, and a Change of Manager to Mr. Paul Anastasio on the All Alcohol Veterans Club License for the premises at 777 Plymouth Street.

Mr. Moore read a Disclosure of Appearance of Conflict of Interest filed by Selectman Daniel Lee. Mr. Anastasio explained that business is slow and the overhead is high, so they are looking to expand the number of members, estimated at 700 – 800, with a new marketing strategy. They want to change the name to a 1700's tavern style name. It was mentioned that MGL Ch. 138, Sec. 12 authorizes the sale of alcohol to members only, and to guests introduced by members, but to no one else. Under 204 CMR 2.05, ABCC Regulations, clubs are not allowed to "use any signs, printed matter or other means publicly to advertise the sale of alcoholic beverages within the licensed premises."

Discussion took place among the Selectmen including support for the application and suggestions for amendments to the application. It was suggested that the name of William B. Dalton not be forgotten. Those in attendance who wished to speak were addressed:

Mr. Bob Franklin was against the name change, except if it were the Dalton Club or Post. He said the full members are actually the property owners, and the Post had hard times in the 70's, 80's and 90's. Ms. Amy Pierce spoke in favor of the name change.

Mr. Eryc Courmac, a veteran, said the veterans need a place to go, and supported keeping the doors open.

Mr. Andy Best, the Commander, said there will be no Post if this change is not approved.

Mr. Anastasio explained that the name change is a marketing strategy. If people see it as a new place, they may stop in. Currently, the building is closed.

for two weeks

The MOTION was WITHDRAWN by Mr. Moore, seconded by Mr. Moriarty.

A meeting will be scheduled for September 7<sup>th</sup>. Mr. Anastasio will meet with Mr. Gordon and Mr. McGaughey prior to that meeting.

Chief McFadden presented the ambulance abatements for the quarter including April 1, 2016 through June 30, 2016. It was noted that these abatements represent bad debts and other adjustments to be written off.

Mr. Gordon explained that a by-law was recently adopted at town meeting that allows the Town to lien Inspectional Services' violations of problem properties to the tax bill. In conjunction with that by-law, the Town needs a policy that lists who is responsible for what. This policy has been reviewed by D'Ambrosio and Brown, the Town's tax title attorneys.

Town of Holbrook INSPECTIONAL SERVICES CODE ENFORCEMENT POLICY, as

Chief Smith requested that the Board approve the use of Lynch's Towing Service for large and heavy duty vehicles.

the constant running of water from a hydrant to keep the water clear

Mosesso Drive, in Holbrook, Norfolk County, Massachusetts, from the intersection of Pine Street, thence approximately .18 miles to a Dead End shown on a plan entitled "Beech Tree Estates Mathematical Corrective Plan of Land in Holbrook, Mass. prepared for Absolute Builders, LLC" dated October 7, 2004 by The Russell A. Wheatley Co., Inc. Land Surveyors & Engineers, which said plan is recorded with the Norfolk County Registry of Deeds in Plan Book 532, Pages 17 and 18.

Oak Street, in Holbrook, Norfolk County, Massachusetts, from the intersection of Sycamore Street, thence approximately .25 miles to a Dead End shown on a plan entitled "Sycamore Woods Plan of Land Oak Street, Chestnut Lane & Aspen Way, Holbrook, Norfolk County, MA" dated September 19, 2005 by Yunits Engineering Co. Inc., which said plan is filed with the Norfolk County Registry District of the Land Court as Land Court Plan No. 27850E filed with Certificate of Title No. 171416.

Ture Lane, in Holbrook, Norfolk County, Massachusetts, from the intersection of South Franklin Street, thence approximately 0.08 miles to a Dead End shown on a plan entitled "Plan & Profile Ture Lane, Holbrook, Mass." by Leverault Engineering, which said plan is recorded with the Norfolk County Registry of Deeds in Plan Book 422, Page 389.

Twinbrook Avenue, in Holbrook, Norfolk County, Massachusetts, from the intersection of Reeds Lane, thence approximately .17 miles to Belair Drive shown on a plan entitled "Belair Estates, A Definitive Subdivision, Holbrook, Mass." dated April 20, 1999 by Miller Engineering, which said plan is recorded with the Norfolk County Registry of Deeds in Plan Book 485, Page 231.

The purpose of these Orders of Taking is to establish said roadways as public ways with appurtenant public utilities. These Orders are made pursuant to a vote of the Holbrook Special Town Meeting on May 11, 2016 under Article 18 accepting said roadways as public ways and a vote of said Special Town Meeting on May 11, 2016 authorizing the Board of Selectmen to acquire by eminent domain a portion of said roadways that has not been conveyed otherwise to the Town. Included in the takings are any trees or structures which may stand upon the land taken. No damages are awarded for this taking. Betterments are not to be assessed on account of these takings. The supposed owners of the premises taken by these Orders are set forth on Exhibit A attached thereto.
