The meeting was called to order at 7:00 p.m. by Chairman Moore, in the Selectman Noel C. King Meeting Room, Holbrook Town Hall, Floor 3R, 50 North Franklin Street, Holbrook, MA 02343.

A moment of silence was observed in memory of Watertown Firefighter Joseph A. Toscano, who died recently while on duty.

Mr. Chuck Greely of Weymouth Street and Mr. Edward O'Keefe of Loud Road expressed concerns about 32 acres of land abutting the Town Forest, which the Town took through the tax title process. Mr. Moore explained that it will be sold at a public auction, and that the majority of the land will be kept as open space under the terms of the sale.

It was announced that:

- Norfolk County Register of Deeds, William P. O'Donnell will be visiting the Council on Aging on Tuesday, April 4, 2017 at 10:00 a.m.
- Sunday, April 30th, from 1 4 pm, the Last Chance Walk-Through Event will be held at Holbrook Junior-Senior High School. 60 years' worth of students are invited to tour the building before it is demolished this summer.
- Fuel assistance applications are available at the Community Development Office and the Town Clerk's office, as well as the Public Library and Council on Aging.
- The Cultural Council is presenting "Curtains Up!", a one-day theatre workshop for children and teens on Saturday, April 22, 2017. Those who wish to participate must be pre-registered.

The Town is working with Mr. George Woodbury, a consultant, and the Metropolitan Area Planning Council (MAPC) in order to inventory, purchase and retrofit the streetlights with LED bulbs. Chapter

90 money can be used for this purpose. A grant has also been approved through MAPC. The Braintree Electric Light Department (BELD) will maintain the lights.

Chief Smith explained that Director Hooke received a 9-1-1 Regional Center Development Grant, which includes the purchase and installation of laptops and printers in the Police cruisers. The purchase has gone out to bid, and he recommends that the Board award the bid to the one responsive qualified bidder.

Representatives of Eversource Energy were unable to attend this meeting.

Elaine Hyland, a resident of Damon Ave., presented information she has gathered from other towns about the Walpole to Holbrook Project passing through their town. There have been various issues raised, including landscaping, traffic flow, etc. She attended a meeting in Stoughton recently, and Stoughton continued the hearing because the company has been non-responsive to the residents. Mr. Moriarty was interested in finding out whether they can be required to post a bond.

Department Updates:

Director Hooke said all of the old 9-1-1 equipment has been removed. Services for Canton Fire are moving forward. There was an apartment fire in Abington, a fire in Rockland and an armed robbery in Holbrook.

Chief McFadden went to the fires in Abington and Rockland. Holbrook Fire provided assistance to Randolph Fire during the wake for FF Joseph Toscano in Randolph. Engine 2 is out for its first service. The Office of Emergency Medical Services performed its annual inspection, and Holbrook received a good report.
