Selectmen Lee and Moore were each re-elected for 3-year terms at the Annual Town Election on April 4, 2017. The Town Clerk swore them both in at this meeting.

Selectman Moriarty spoke about SOLICITORS coming to his door at this home. There are NO permits issued to anyone to go door-to-door to sell anything in Holbrook. Residents were urged to contact the Police when someone is soliciting in their neighborhood.

Mr. John Smith, a former resident who grew up in Holbrook, spoke about Mr. LONNY MCGAUGHEY who recently passed away. Mr. Smith suggested that a ball field at the Sumner Field be named in memory of Mr. McGaughey and his dedication to sports in Holbrook. Selectman McGaughey said his brother was very humble and probably would not want this honor. Different athletic fields were discussed. It was suggested that the Board find out about a field at the new school, or a farm or softball field.

Stephan Hooke, Director of the Public Safety Communications Department, spoke about the unseen first responders in an emergency – the Dispatchers – and thanked them for their work. Several of the Dispatchers were present. A proclamation was read recognizing NATIONAL TELECOMMUNICATOR WEEK.

Ms. Denise Hinckley, representing four churches that make up the HOLBROOK COMMUNITY OF CHURCHES, requested the use of the Sumner Field for a movie night on July 1, 2017. Mr. Lee asked that the time of the event be changed to 3:00~pm-8:00~pm, instead of 4:00-9:00. Ms. Hinkley indicated that they could make the change. There are no lights available at that field.

Community of Churches to use the Sumner Field on July 1, 2017 from 4:00 - 9:00 pm, with the time subject to change, and a certificate of insurance from one of the churches

PUBLIC HEARING CONTINUED: Eversource Energy Walpole to Holbrook 115-kV Reliability Project (originally opened on March 8, 2017. Project proposes to add a new transmission line on the vacant side of existing towers between Centre Street and the existing Holbrook Substation on Pine Street. Requires the aerial crossing of N. Franklin St., Centre St., Scott St., Westdale Rd., Damon Ave. and Pine St.

Walpole to Holbrook 115-kV Reliability Project

Mr. Lopes explained that the company is waiting for a grant of location and final approval, with a deadline in 2018.

Atty. North said there is an ongoing petition pending under Chapter 156 Section 22, because of the need to go over public ways in Holbrook. She advised that there are several known details about the project that have not been included in the draft documents, such as the kind of lines, the number of cables, the height it may run, a plan reference, etc. If the Town grants it, there is no authority to revoke it. However, if the Board does not grant it, the Board of Selectmen can be overridden. Atty. North explained that any environmental areas of concern and the buffer zone are addressed by the Conservation Commission, which has issued an order of conditions.

A brief discussion took place about the issues raised in other towns the project is going through, particularly Stoughton where there are resident concerns about the mitigation and landscaping. Mr. Lopes said all of the 2006 mitigation has been taken care of in Stoughton except the installation of a traffic signal at Rte. 138 and York Street, which cannot be completed because it is a state highway. Walpole, Canton and Randolph have all signed.

Mr. Lopes said that the project is to install 3 lines, top to bottom, with a minimum clearance of 25 feet to the ground. The work will be completed Monday – Friday, and they will work with the Police on the crossings. Mr. Lopes' colleague said work would be done Saturday & Sunday where they can, and during off peak hours, usually 9 am - 3 pm, Monday through Friday. No detours are planned. Work is only done in the daytime if a bucket truck is needed. Atty. North said this known information should be added to the revised order before the Selectmen approve it.

FY2018 Budget Proposal for Town Meeting:

Present: Kevin Costa, Chairman, Finance Committee

The proposed FY2018 budget was compared to the FY2017 budget. The budget for FY2018 is much tighter and more difficult. There has been a jump in school transportation, and Mr. Costa suggested that our legislators be asked to rework the Chapter 70 formula. The gasoline expense has been broken up by department for FY2018, instead of one line item in the Public Works budget. Mr. Costa asked Town employees to think about choosing a less expensive health insurance plan. The property insurance will see an increase due to the new school building and the vacant elementary schools.

The Police Department will be receiving TABLETS FOR THE POLICE CRUISERS AND PRINTERS, funded through a grant. The low bidder has been identified and is recommended.

MOTION: By Mr. Moriarty, second by Mr. Sheehan, that the Board of Selectmen vote to authorize

the Chairman to execute a contract between the Town of Holbrook and Advanced Electronics Design, Inc. AKA Patrol PC for the purchase and installation of 10 tablets and 5 mobile printers for the Holbrook Police Department, at an amount not to exceed

\$68,616.00

The RENOVATION OF UNION STREET is on the Traffic Improvement Program (TIP) for 2020. If it is ready to go earlier, there is a possibility it could be moved up on the plan. BETA Engineering will be bringing the project up to 75% design.

Chairman to execute an Agreement for Professional Services between the Town of Holbrook and BETA Group, Inc. for the 75% Design of the Union Street Roadway

Improvements Project for a Total Fee of \$139,500.00

The Police Chief, Fire Chief and Director of Communications have been reimbursed for their monthly CELL PHONE costs. However, their contracts do not refer to cell phone reimbursement. Voting on it now will provide the Town Accountant with the legal authority to reimburse them.
