Mr. Gordon reported that:

- The streetlights have been purchased by the Town from National Grid. The engineering of the new system is being completed, with a target date to finish before winter.
- A rate study on water is being done because of a revenue concern.
- Daniel Daly, the Supervisor in the Public Works Department, is retiring at the end of July after 40 years.
- There is nothing new to report on the auctioning of the "32 acres" abutting the Town Forest.
- No parking signs have been posted on North Shore Road.

One member of the Conservation Commission, who resigned in June, and then rescinded his resignation, was not on the appointment list in June due to the timing of the vote on annual appointments.
