The meeting was called to order at 7:00 p.m. by Acting Chairman Sheehan, in the Selectman Noel C. King Meeting Room, Holbrook Town Hall, Floor 3R, 50 North Franklin Street, Holbrook, MA 02343, and began with the Pledge of Allegiance.

A moment of silence was observed in memory of Mr. Richard Monteith, a beloved teacher and coach at Holbrook Junior-Senior High, who passed away recently.

It was announced that the February  $9^{th}$  and  $10^{th}$  trash pickups will be postponed one day each, due to an impending snow storm.

Mr. Gordon reported that the next Selectmen's meeting will be held in the former Selectmen's Meeting Room on the first floor, and there will be a ceremony to re-name it the HERITAGE ROOM. The Historical Commission and Society are preparing pictures and other articles for display in the room.

Building Commissioner Dan Moriarty was present to update the Board on 394 SOUTH STREET. He explained that the homeowner contacted the State Building Inspector. The Inspector went through 3 years of the Inspectional Service Department's records on the property, visited the property, and advised the homeowner to clean the property, and the building permit will be issued.

Applications have been received for an ALTERNATE BUS/VAN DRIVER for the COUNCIL ON AGING. One resident applied, was found qualified, and was recommended by Town Administrator Gordon.

## Department Updates:

Fire Chief McFadden reported that there have been numerous car accidents lately, and cautioned residents to be careful during the upcoming storm.

Police Chief Smith presented the Board with model language for town meeting relative to recreational marijuana that he got from a Chief's organization. One new recruit will graduate from the academy on February 15<sup>th</sup>.

Communications Director Hooke said the Next Generation 9-1-1 was installed last week, and the cut over will be March 1<sup>st</sup>. There will be a public relations campaign prior to the dispatchers starting to receive texting, videos, etc. He thanked the Fire Department for assistance in restoring services following an accident on North Quincy Street that took down a communication wire and triggered the use of the backup system.

Superintendent Ecord said his department has been working on pot holes and is ready for snow. Work will be done on Crescent Drive in the spring under an emergency waiver.

Treasurer/Collector Digirolamo said collections are coming in as usual. \$31,000 was collected in January from Tax Title.

It was explained that this hearing was continued because the full Board was not able to attend the last meeting.

Building Commissioner Daniel Moriarty, Jr. spoke on behalf of his own position and that of the Plumbing/Gas Inspector. He discussed an increase in the number of projects, and more time being spent in the office.

Communications Director Hooke explained that he did an analysis of the part-time Dispatchers' hourly rate. Currently, they make \$15.91/hr. Other area towns are paying dispatchers \$20/hr. and up to \$24/hr. The part-timers work approximately 3,758 hours per year.

The hearing will be continued again because only 3 members of the Board could attend this meeting.
